## 4. Assess intelligent automation and workflow capabilities:

- Determine if the IDP solution offers intelligent document routing and helps in creating customized processing workflows.

#### 8. User experience and training:

- Evaluate the solution's user interface and ease of use for both technical and non-technical users.
- Check if the vendor provides comprehensive training and support resources to facilitate implementation and user adoption.

# 9. Total cost of ownership (TCO):

- Consider the overall cost of implementing and maintaining the IDP solution.
- Evaluate pricing models, including licensing fees, deployment costs, and any additional charges for customization or integration.
- Factor in the long-term ROI (return on investment) and potential cost savings from improved efficiency and productivity.
- Hosting and deployment options where will the solution reside (own environment v/s vendor environment).
- Engagement model (SaaS, PaaS, Custom Build & Transfer, etc.).
- What is the commercial structure (packaged offering vs a la Carte/pay-per-microservice).

- Request demos or trial periods from shortlisted vendors to assess the solution's functionality and suitability.
- Involve key stakeholders in the evaluation process to gather feedback from different perspectives.
